FUND AIM

The L&G ESG Emerging Markets Corporate Bond (USD) UCITS ETF (the "ETF") aims to track the performance of the J.P. Morgan ESG CEMBI Broad Diversified Custom Maturity Index (the "Index"). More information on the Index can be found on page 2 of this document.

WHO IS THIS FUND FOR?

- The ETF is designed for investors looking for a combination of growth and income from an investment in eligible liquid, US Dollar-denominated, emerging market, fixed and floating-rate corporate bonds which can form part of their existing savings portfolio.
- Although investors can take their money out at any time, this ETF may not be appropriate for those who plan to withdraw their money within five years.
- This fund is not designed for investors who cannot afford more than a minimal loss of their investment.
- If you do not understand the information in this document, the key information document or the prospectus, we recommend that you seek additional information or advice to help you decide if this ETF is suitable for you.

FUND SNAPSHOT

The L&G ESG Emerging Markets Corporate Bond (USD) UCITS ETF aims to provide exposure to liquid, US Dollar denominated emerging market fixed and floating-rate debt instruments issued by corporates.

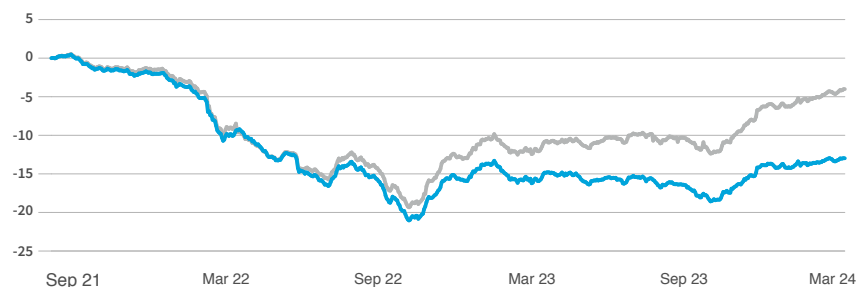

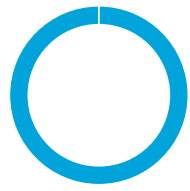

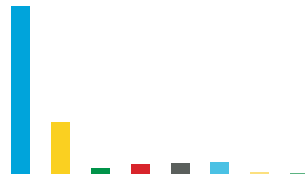
PORTFOLIO BREAKDOWN

INDEX DESCRIPTION

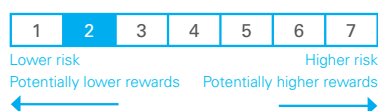
The Index tracks the performance of eligible liquid, US Dollar-denominated, emerging market, fixed and floating-rate, debt instruments issued by corporate entities. The index applies an ESG scoring and screening methodology to tilt toward issuers ranked higher on ESG criteria and green bond issues, and to underweight and remove issuers that rank lower.

INDEX FUND MANAGEMENT TEAM

The Index Fund Management team comprises 25 fund managers, supported by two analysts. Management oversight is provided by the Global Head of Index Funds. The team has average industry experience of 15 years, of which seven years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.
