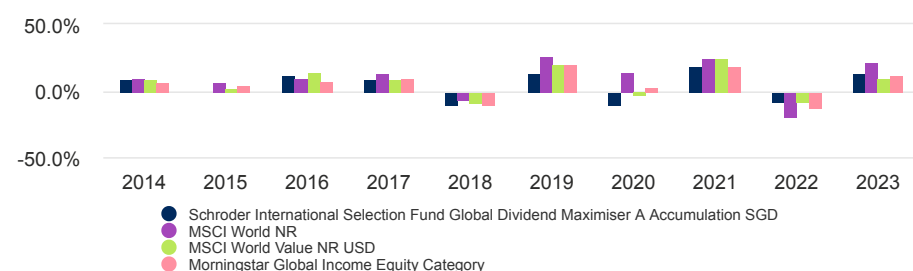

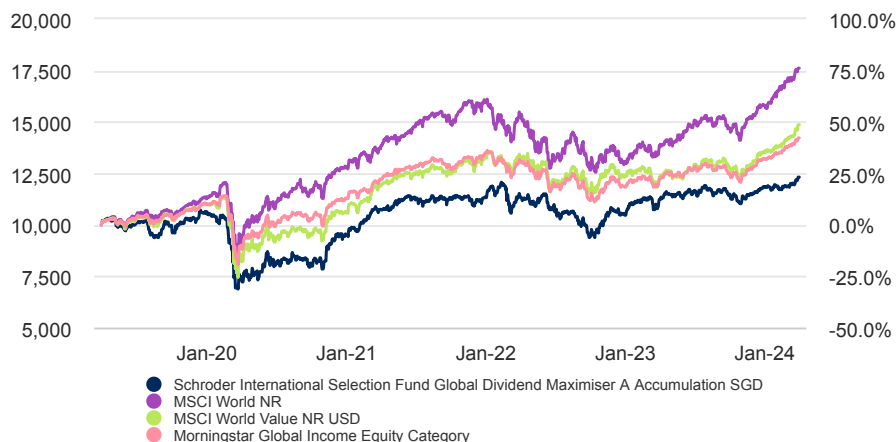

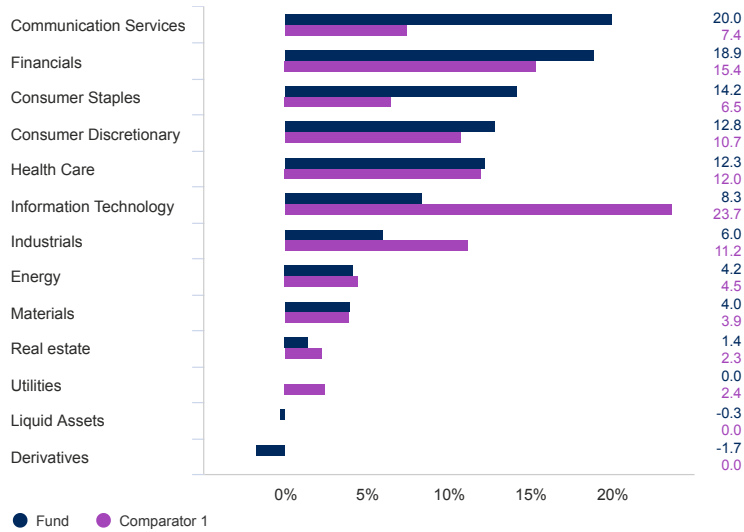

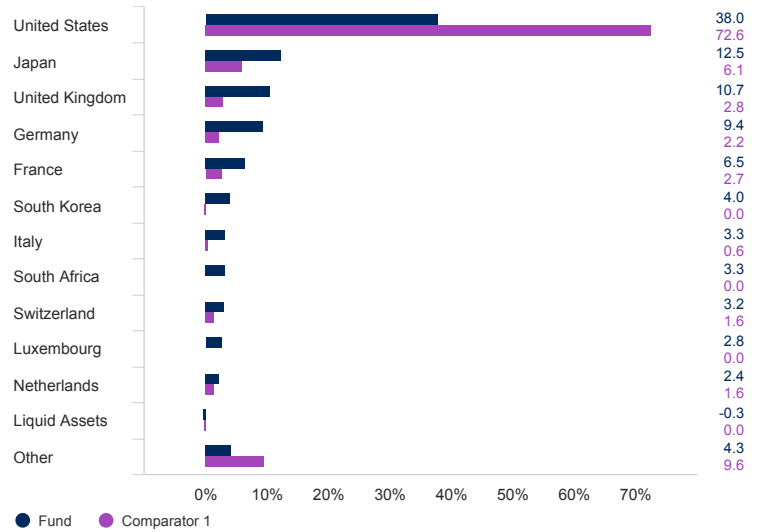

Asset allocation

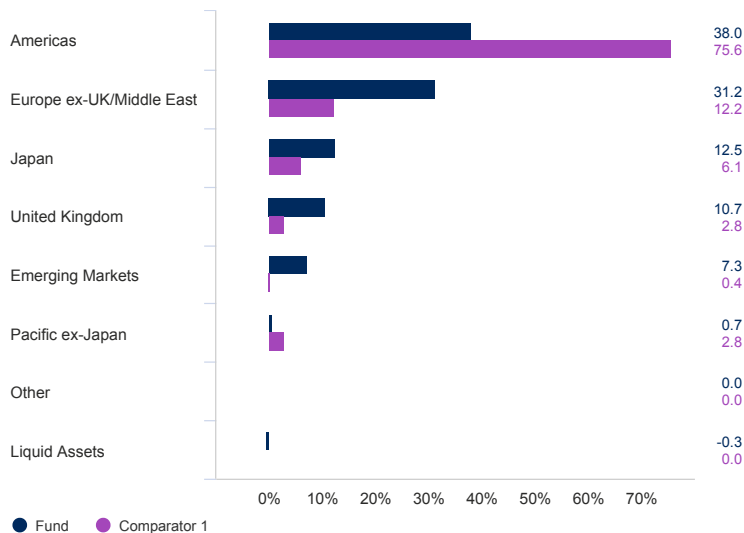
Sector (%)
