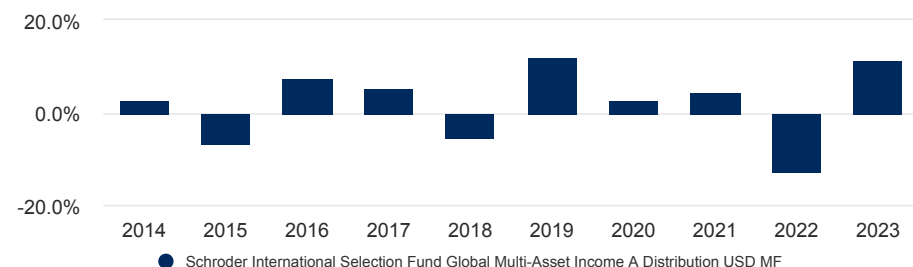

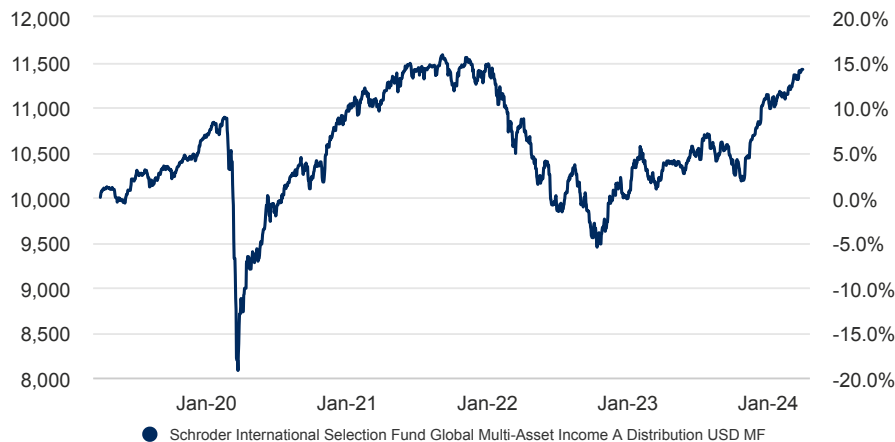

### Return of USD 10,000

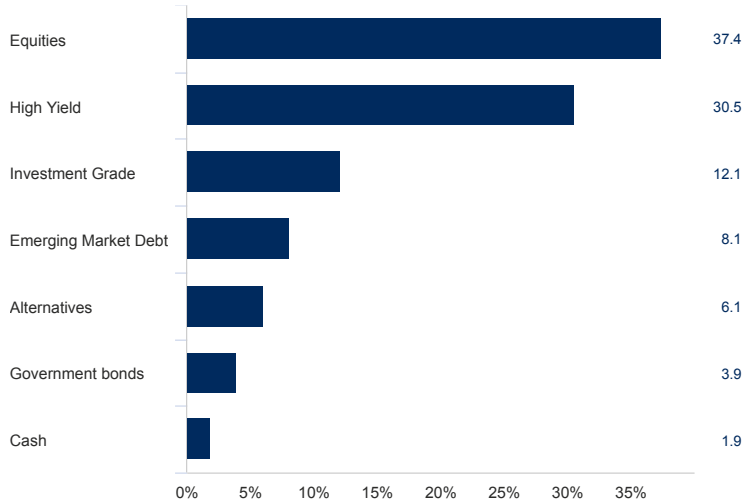

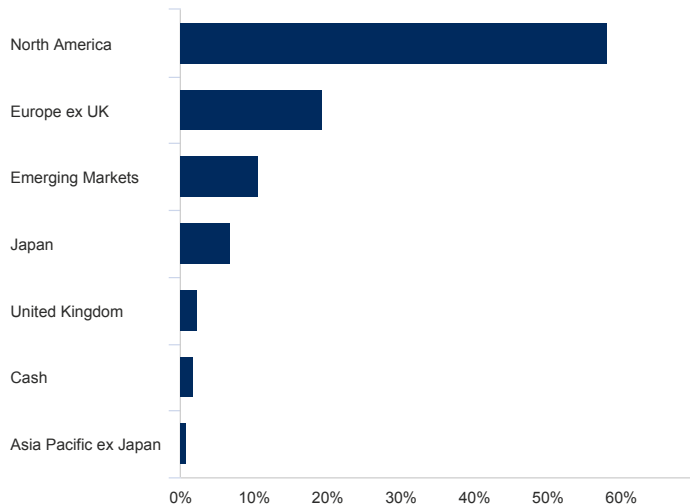

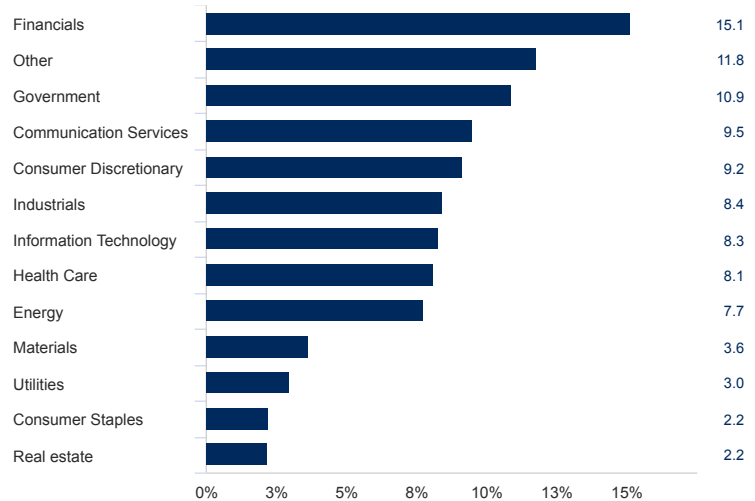
