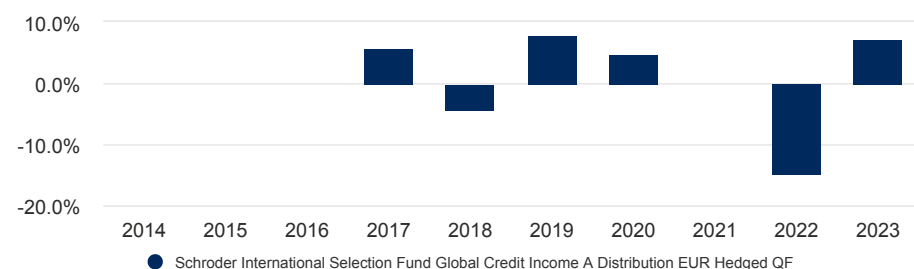

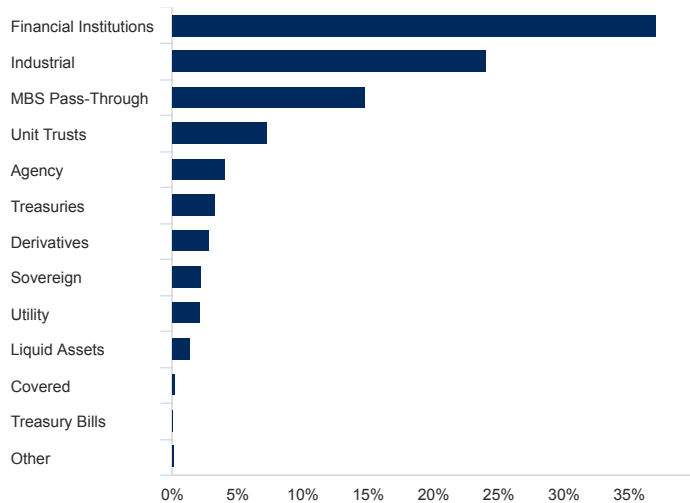

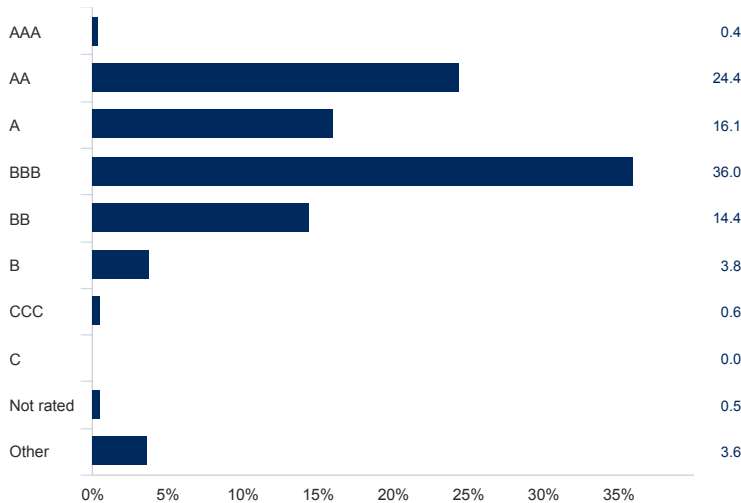
Asset allocation

Sector (%)



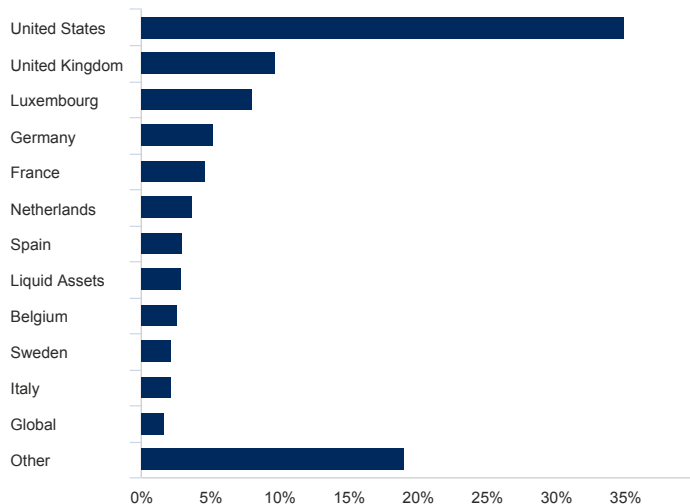
