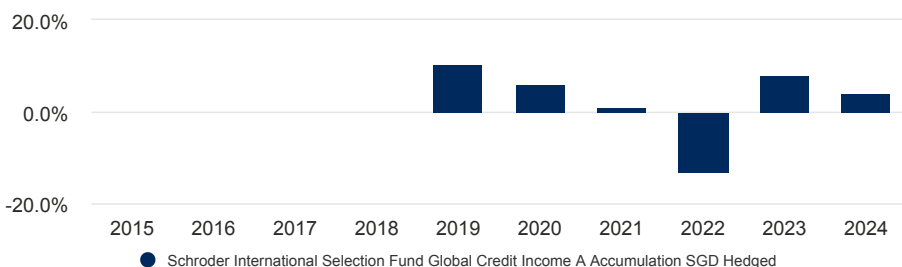

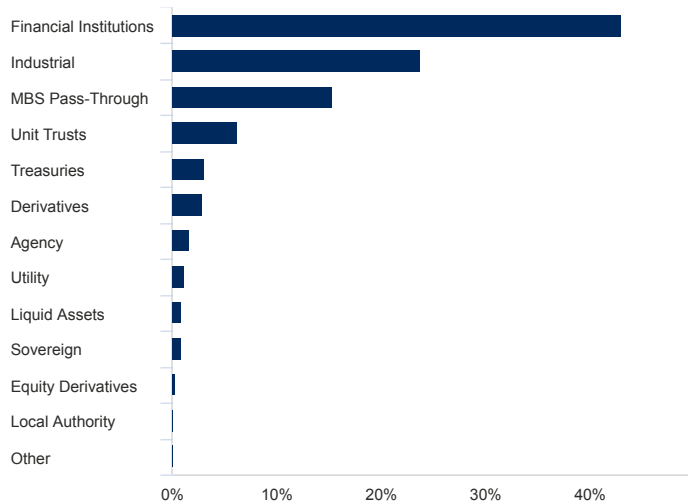

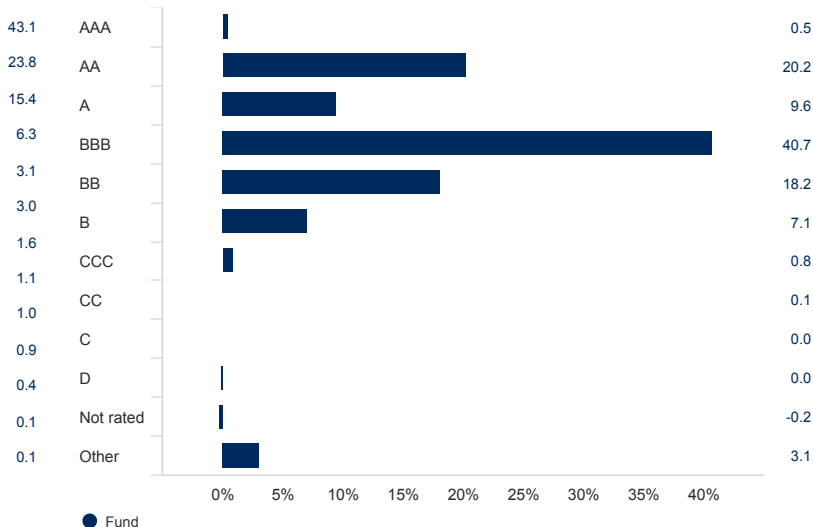

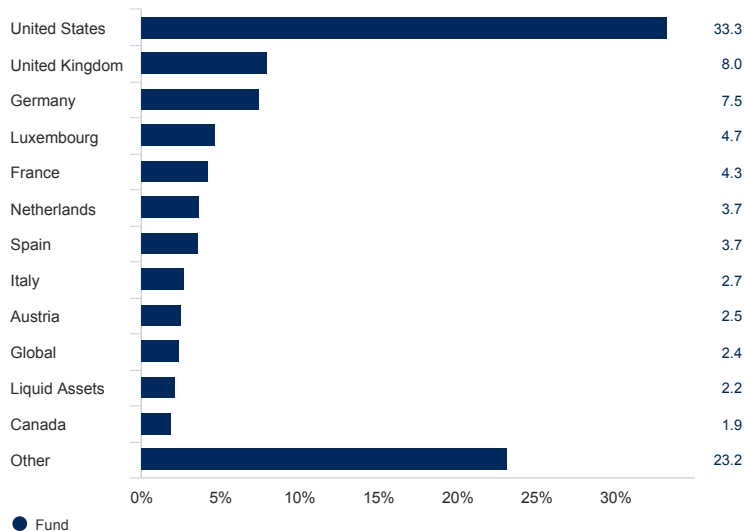
Sector (%)
