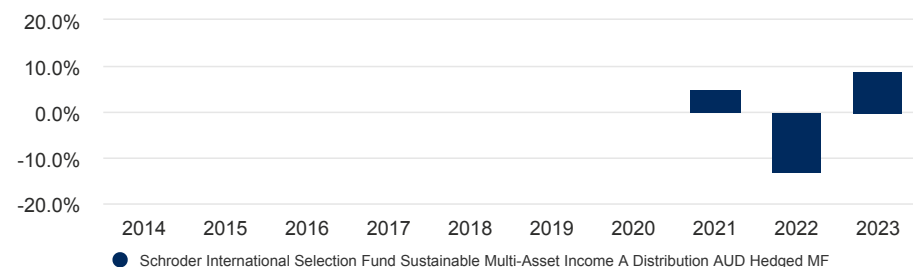

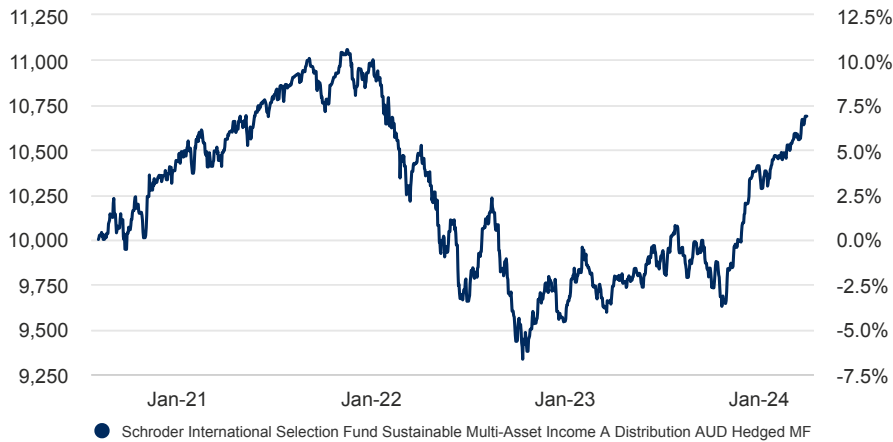

Return of AUD 10,000

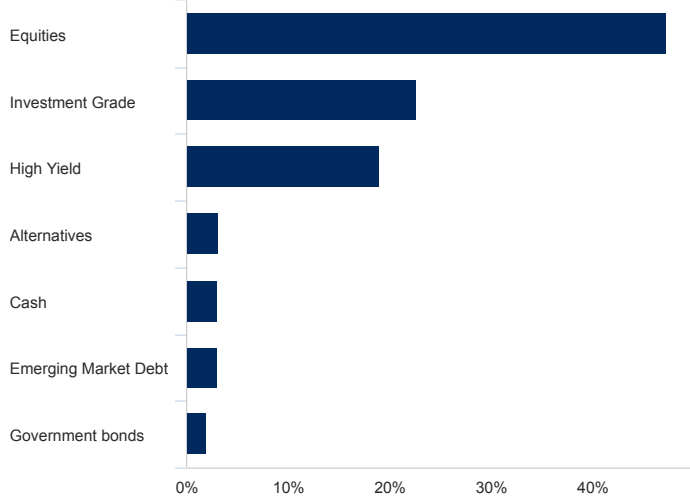

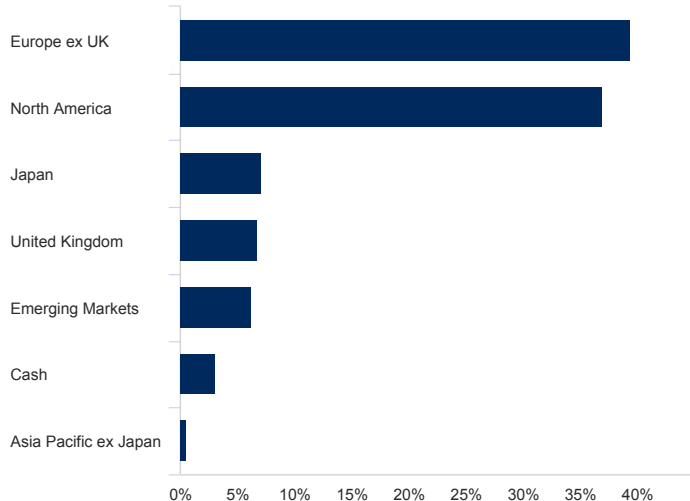

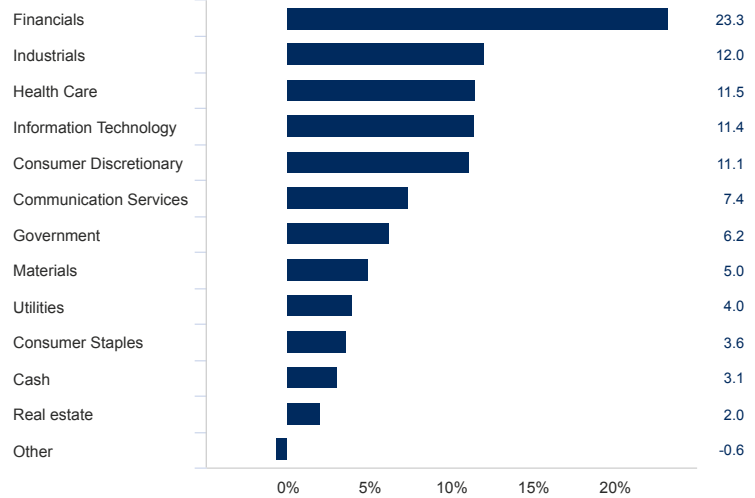
Asset class (%)
