# GLOBAL EQUITY CLIMATE CHANGE

### Investment objective

The Fund aims to provide long term capital growth and income by investing in a portfolio of shares. In particular, the Fund invests in companies that may benefit from the transition to a low carbon economy by having a higher environmental, social and governance rating compared of its reference benchmark. The Fund qualifies under Article 8 of SFDR.



### Investment strategy

The Fund is actively managed. In normal market conditions, the Fund will invest at least 70% of its assets in shares (or securities similar to shares) of companies of any size with revenue exposure to climate transition themes. The Fund invests in companies, that are based in, or carry out the larger part of their business activities in, both developed markets and emerging markets. The Fund can invest up to 20% in China A and China B-shares. For China A-shares, up to 10% through the Shanghai-Hong Kong Stock Connect and/or the Shenzhen-Hong Kong Stock Connect, and up to 10% in CAAPs. The Fund may invest up to 10% in Real Estate Investment Trusts, and may also invest up to 10% in other funds, including HSBC funds. See the Prospectus for a full description of the investment objectives and derivative usage.



### Main risks

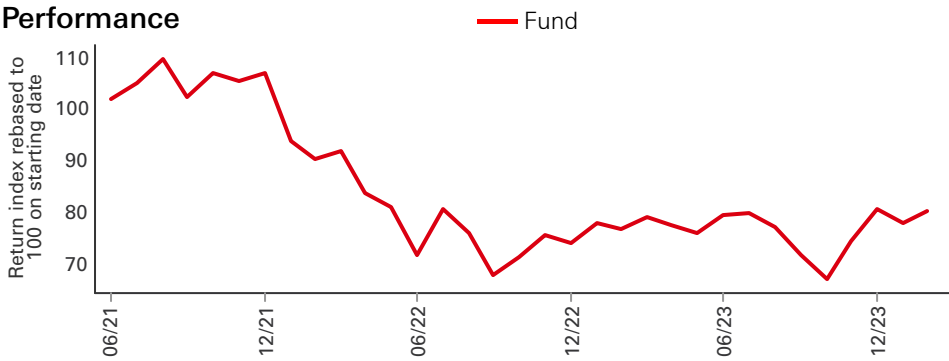

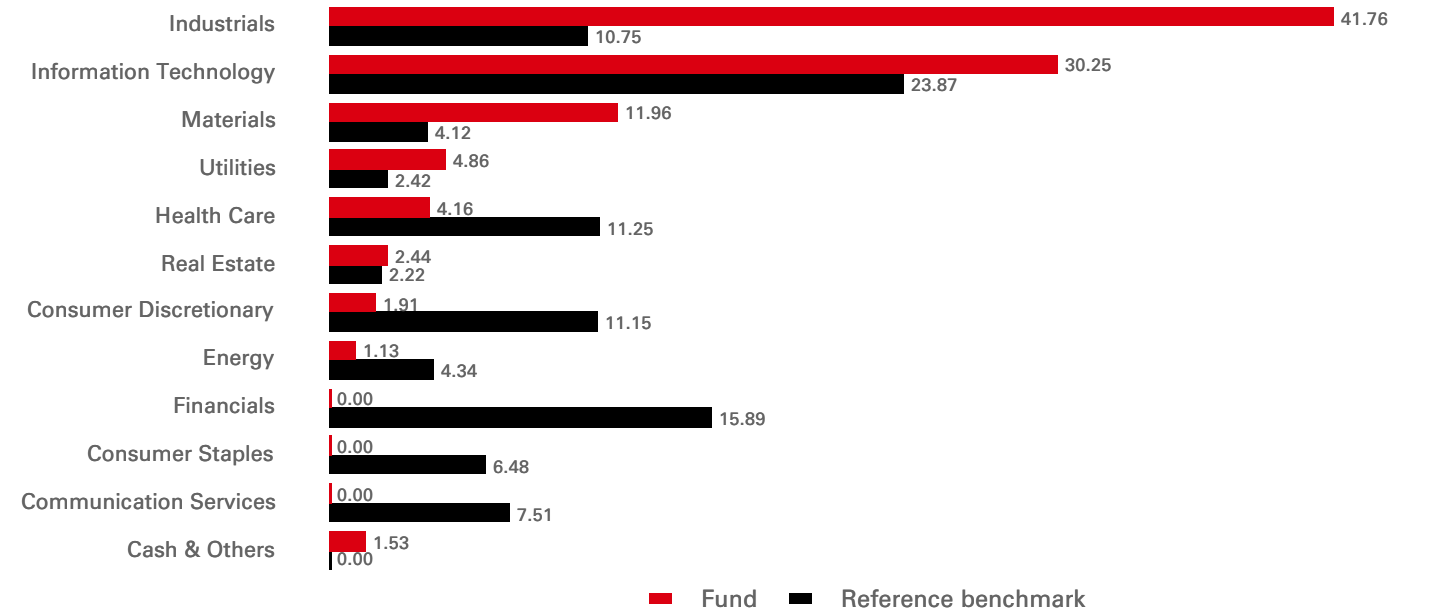

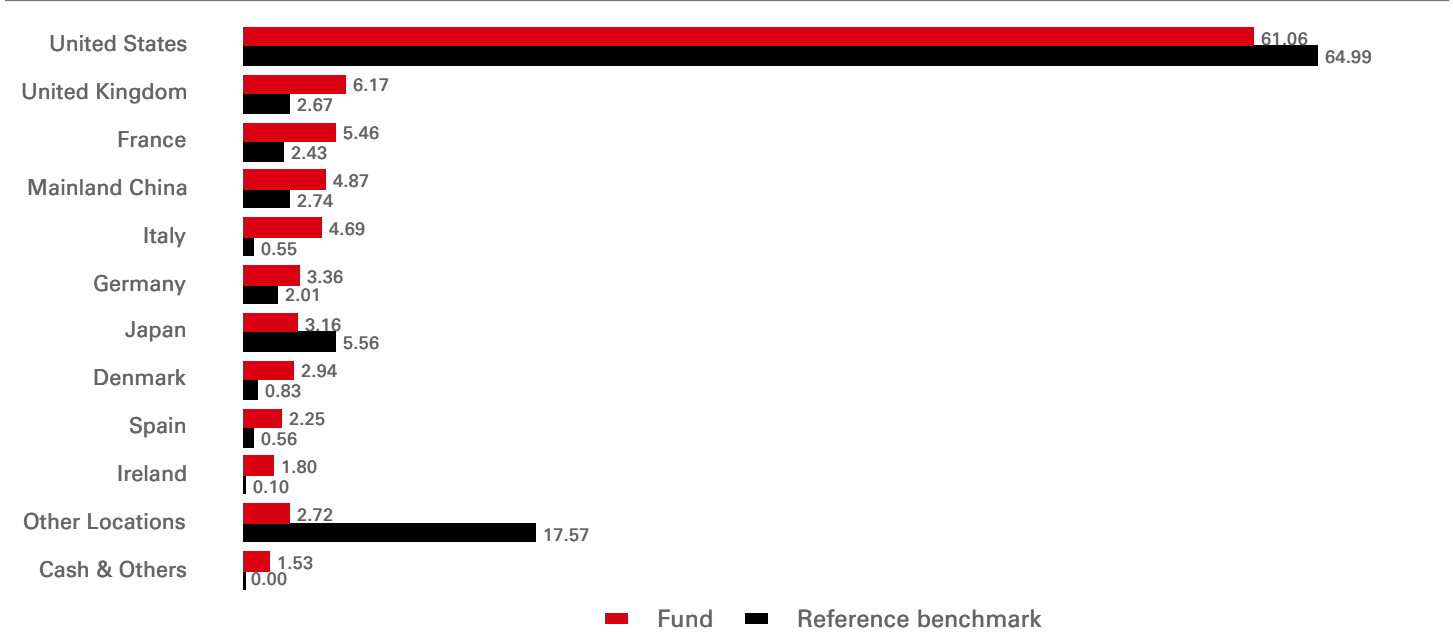

## Monthly performance commentary

At sector level, stock selection was negative for the month. Positive performance came from Materials and Industrials, though this was offset by negative stock selection in Information Technology and Utilities.

At country level, stock selection was negative for the month. Positive performance came from USA and Italy, though this was offset by negative stock selection in Japan and Spain.

USA Industrials security, SCHNEIDER ELECTRIC SE with total effect 0.43% was the top contributor. Additionally, USA Materials security, ECOLAB INC was the second largest contributor with total effect 0.38%. USA Industrials security, ADVANCED DRAINAGE SYSTEMS IN also contributed with total effect 0.37%.

On the other side, detractors included Spanish Utilities security EDP RENOVAVEIS SA with total effect -0.58%, USA Information Technology holding, NVIDIA CORP with total effect -0.55%, and Finnish Energy holding, NESTE OYJ with total effect -0.37%.

During this period, positions were initiated in CADENCE DESIGN SYS INC. Positions were closed in NIBE INDUSTRIER AB, and BRENNTAG SE.

Sector and Country allocation effects are residual to stock selection. At a country level, effects were negative, given an underweight exposure to Spain. At sector level, effects were positive, given an overweight exposure to Industrials.
