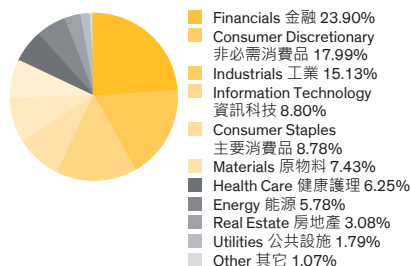
Important Information 重要事項

- The fund invests primarily in equity securities of companies that are organized, or have substantial business activities, in India.
本基金主要投資於在印度成立或有大量業務的公司之股本證券。

Portfolio Objective/ Strategy/ Key Features 基金目標/ 策略/ 特色

The Portfolio's investment objective is to increase the value of your investment over time through capital growth. In actively managing the Portfolio, the Investment Manager uses fundamental research to select securities that it believes offer superior long-term growth characteristics (bottom-up approach). Under normal market conditions, the Portfolio typically invests at least 80%, and not less than two thirds, of its net asset value in equity securities of companies that are organised, or have substantial business activities, in India. These companies may be of any market capitalisation. The Portfolio's exposure may include convertible securities, participatory notes and depositary receipts.

本基金的投資目標是透過資本增長隨時間增加閣下的投資價值。在以主動式管理本基金時，投資管理人運用基本因素研究，挑選其認為可提供卓越長期增長特點的證券（由下而上方法）。在正常市場狀況下，本基金將至少 80% 及不少於三分之二的資產淨值投資於在印度成立或有大量業務的公司之股本證券。此等公司可屬任何市值。本基金可持有可換股證券、參與票據及預託證券。

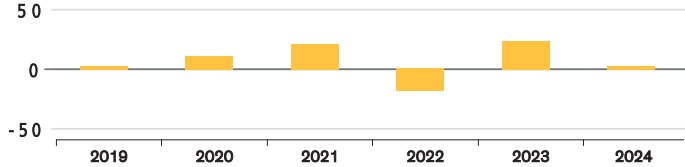

~二零零九年十月三十一日，因聯博－印度增長基金(AllianceBernstein – India Growth Fund) 併入 ACMBernstein SICAV 成為旗下的一個投資組合，本基金英文名稱更改為 AllianceBernstein–India Growth Portfolio，而中文名稱維持不變。兩基金的投資目標、政策、策略以及費用和收費相同。於 2009 年 6 月 15 日，A 類股份更名為 AX 股，而此股份將不再接受新投資者認購。新投資者可認購基金所推出的新版 A 類股份。請注意於第 2 頁內所有「成立迄今」的表現均以 2009 年 6 月 15 日起計算。

On 15 July 2021, the Portfolio had a Share Class split exercise, each base currency share class (which includes the Other Offered Currency Share Classes (the "OOC Share Classes")) was restructured into multiple share classes through a split. In addition to the base currency share class of a Portfolio, each OOC Share Class will now become a distinct share class denominated in the relevant offered currency as further described in detail in the Prospectus. There were no change in the investment objective, policies and strategies of the portfolio. Inception Date refers to the inception date of the share class before the split exercise.
